There is an unusual irony in the excellent letter in your issue of February 27 reproving the Board of Directors of channel 13 for their decision to show "The Merchant of Venice". The actual story, which Shakespeare copied as he did so many others, involved a Christian's cruelty to a Jew. More than a decade before

Shakespeare represented Shylock as seeking a pound of flesh from Antonio, the story was written by Gregorio Leti in 1587 in a hiography of the then reigning pontiff. Sixtus V. A. Roman Christian merchant, Secci, wagered a thousand scudi against a Jewish merchant's pound of flesh, on the truth or falacy of a report of a raid on San Domingo by Drake. Secci won his bet and insisted on his pound of flesh, refusing monetary compensation. The problem was resolved by the Pope, who used the same out that Shakespeare writes about: the winner must not cut more or less than a pound of flesh under penalty of his own death.

Pope Sixtus, perhaps the * sternest of all in the long line that wore the papal crown, then imprisoned both these betting gentlemen and sentenced them to death.

Shapespeare, who kne few if any Jews, who wer not formally readmitted t England for another half century, reversed the char acters.
