Dear Mr. Blumenberg:

We have inspected that the "Eruv" installed under the above approval is not in accordance our rules and regulations. You are hereby instructed to correct all deficiencies within two weeks from receipt of this letter. Otherwise we will revoke our approval and order our maintenance contractor to remove them at your expense.

Please note that our approval is only for street light lampposts. The following deficiencies must corrected at an earliest.

1. Boards and Metal pipes are not permitted on City of New York street light poles and must be removed. Only approved eye loops on top of street light lamppost are permitted.
2. Boards and metal pipe are not permitted on DOT signs or railings and must be removed.
3. Attachment to Con Edison and Telephone poles must be approved by those authorities.
4. Attachment to Subway structures must be approved by New York City Transit Authority.
5. No private signs are permitted attached to street light lampposts and must be removed.
6. Boards and other attachments are not permitted on the trees due to safety reasons and must be removed.

Please note that Eruv installation must comply with the plans and drawings you have preciously submitted and approved by us. Please notify us for our final approval once you have corrected all deficiencies. I have attached herewith a copy of the rules governing Eruv installation for your reference.
